

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.bradshawfinancialservices.com](http://www.bradshawfinancialservices.com), and Bradshaw Financial Services LLC and governs data collection and usage. By using the Bradshaw Financial Services LLC website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, Bradshaw Financial Services LLC may collect personally identifiable information, such as your:

We do not collect any personal information about you unless you voluntarily provide it to us. ## Sharing Information with Third Parties
